## ASSIGNMENT OF INTANGIBLE ASSETS

THIS ASSIGNMENT OF INTANGIBLE ASSETS (this "Assignment") is entered into as of the 29 day of June, 2018 by Motor Home Specialist, L.P., a Texas limited partnership, ("MHS"), John Douglas O'Banion, a resident of the state of Texas ("DO"), Sharon O'Banion, a resident of the state of Texas ("SO"), O'Banion Irrevocable Trust for Roy Donavon O'Banion ("RO"), O'Banion Irrevocable Trust for Patrick O'Banion ("PO"), O'Banion Irrevocable Trust for Paul O'Banion ("POB"), O'Banion Irrevocable Trust for Tyler O'Banion ("TO"), and O'Banion Irrevocable Trust for Robert Brake, Jr. ("RB") (collectively, MHS, DO, SO, RB, RO, PO, POB, and TO (the "Assignor"), to and for the benefit of RV Retailer Texas, LLC, a Texas limited liability company ("Assignee").

### RECITALS

A. MHS owns and operates a recreational vehicle business (the "Dealership"), located at 5411 S. Interstate 35W, Alvarado, TX 76009-6381 (the "Dealership Property").

B. Assignor, as "Seller," and RV Retailer Holdings, LLC, a Delaware limited liability company ("RVRH"), as "Buyer," are parties to that certain Asset Purchase Agreement dated as of April 6, 2018, as amended (the "Purchase Agreement"), regarding the acquisition of assets related to the Dealership. Capitalized terms not otherwise defined in this Agreement have the meanings given them in the Purchase Agreement.

C. RVRH has assigned all of its rights and obligations under the Purchase Agreement, including those relating to the Dealership to Buyer, including its rights to the intangible assets, under the terms of that certain Assignment and Assumption Agreement dated even date herewith, between RVRH and Buyer.

D. Pursuant to the Purchase Agreement, MHS has agreed to assign and Assignee has agreed to assume Assignor's intangible assets.

NOW, THEREFORE, in accordance with the Purchase Agreement and for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto hereby agree as follows:

### ASSIGNMENT

1. MHS hereby transfers and assigns unto Assignee all of MHS's intangible assets related to the operations of the Dealership, including, but not limited to the following: all operating data and records of MHS relating to the Dealership including, without limitation, exclusive rights in and to the customer lists, leads, and records, deal jackets for new vehicle orders on hand at the Closing Date, correspondence, budgets, and other similar documents and records (but excluding financial and tax records of Assignor which shall remain the property of Assignor), all of the Dealership's registration lists of its new and used vehicles, owner follow-up lists, historical vehicle order information, historical operational records, "hard" copies of service files for work in process and electronic copies of any other service files and lists of new vehicle orders on hand at the

Closing Date, all of the right, title and interest in and to all of MHS's intangible property and rights relating to the products or business of the Dealership, including all rights with respect to telephone numbers, facsimile numbers, e-mail addresses, urls, social media pages, and Internet World Wide Web domain names used by MHS in the conduct of the Dealership's business as listed on Schedule 1 hereto, all of the goodwill and proprietary rights of MHS related to the Dealership, including trademarks trade names and d/b/a names (including, without limitation, "Motor Home Specialist"), licenses, designs, and drawings, computer software, slogans, copyrights, other similar intangible property and rights relating to the products or business of the Dealership or the Dealership Property as listed on Schedule 2, all of MHS's assignable rights arising out of or under any third party express or implied warranty including guarantees, and all interests, rights and benefits accruing to the Dealership under all pending repair work order, any other pending work in process, including all sublet work in process which has been written by the Dealership as of the Closing, but not complete as of Closing.

2. Assignee hereby accepts the Assignment set forth in Section 1 herein.

3. This Assignment shall be binding upon, and inure to the benefit of, Assignor and Assignee, and their respective successors and assigns.

4. This Assignment shall be governed by and construed in accordance with the laws of the State of Texas without giving effect to conflicts of law principles.

5. This Assignment may be executed in one or more counterparts, each of which is an original and all of which constitute the Assignment.


