## TRADEMARK ASSIGNMENT

**THIS TRADEMARK ASSIGNMENT** ("Assignment") is made and entered into as of this fifth day of August, 2013, by and between **Scott Gottschalk, DBA Golf Ball Zone**, an individual residing at 25 Donnell Crossfield Circle, Florida ("Gottschalk"), and **TGIB Marketing, Inc., DBA Rock Bottom Golf** ("TGIB").

### **WITNESSETH:**

**WHEREAS**, Gottschalk owns certain rights, title, and interest in and to the trademark listed in Schedule A attached hereto (the "Mark"), the application associated with the Mark and having the serial number listed in Schedule A (the "Application"), and the goodwill associated therewith (collectively, the Mark and the Application shall be referred to herein as the "Trademark");

**WHEREAS**, TGIB desires to obtain all of Gottschalk's right, title, and interest in and to the Trademark and the goodwill associated therewith; and

**WHEREAS**, Gottschalk is willing to assign its right, title, and interest in and to the Trademark, and the goodwill associated therewith to TGIB.


**NOW, THEREFORE**, for good and valuable consideration, the sufficiency and receipt of which are hereby acknowledged, the parties hereto agree as follows:

1. **Assignment**. Gottschalk hereby sells, assigns, and transfers to TGIB all of Gottschalk's right, title, and interest worldwide in and to the Trademark and the goodwill associated with the Trademark.
2. **Gottschalk's Duties**. Gottschalk agrees to execute any additional legal documents necessary to perfect TGIB's ownership of the Trademark and the goodwill.
3. **Past Damages**. Gottschalk hereby sells, assigns, and transfers to TGIB all of Gottschalk's rights to sue and recover any past damages associated with the Trademark, such as but not limited to trademark infringement damages.

4. **Governing Law.** This Assignment shall be governed by New York State law, excluding its conflicts of law principles, except for any portion hereof that is governed solely by Federal law in which case such law shall govern.

5. **Miscellaneous.** The invalidity or illegality of any provision of the Assignment shall not affect the validity of any other provision. The parties intend for the remaining unaffected provisions to remain in full force and effect. All notices given under this Assignment shall be in writing and sent postage pre-paid to the parties at their respective addresses set forth above. The section headings herein are provided for convenience only and have no substantive effect on the construction of the Assignment. This Assignment may be amended only in a writing signed by authorized representatives of both parties. There are no representations, warranties, or obligations of either party not expressly contained herein. The provisions of this Assignment that by their nature would survive its termination or expiration will survive indefinitely.
