**NOTICE OF RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), effective as of November 13, 2018 is made by CORTLAND CAPITAL MARKET SERVICES LLC, in its capacity as administrative agent (in such capacity, the “Administrative Agent”), in favor of AWARE PRODUCTS, LLC, a California limited liability company (the “Company”).

WITNESSETH:

WHEREAS, in connection with the Security and Pledge Agreement Supplement, dated as of July 31, 2018, among the Administrative Agent, the Company and the other parties thereto, which supplements the Security and Pledge Agreement dated as of March 9, 2017 (as so supplemented and as further amended, amended and restated, joined, supplemented or otherwise modified prior to the date hereof, the “Security Agreement”), the Company executed and delivered the Grant of Security Interest in Trademark Rights, dated as of July 31, 2018, in favor of the Administrative Agent (the “Trademark Security Agreement”);

WHEREAS, pursuant to the Trademark Security Agreement, the Company pledged and granted to the Administrative Agent for the benefit of the Secured Parties a lien on and continuing security interest in all of its Intellectual Property, including the Trademarks set forth on Schedule A attached hereto, together with all goodwill associated with such Trademarks (the “Released Trademarks”);

WHEREAS, the Administrative Agent’s security interest in the Released Trademarks was recorded with the United States Patent and Trademark Office (the “USPTO”) on July 31, 2018, at Reel/Frame No. 6398/0462; and

WHEREAS, the Administrative Agent, at the direction of the Lenders, has been duly authorized to execute, deliver and perform this Release.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent, at the direction of the Lenders, agrees for the benefit of the Company, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the Security Agreement or Trademark Security Agreement, as applicable.

SECTION 2. Release of Security Interest. The Administrative Agent does hereby release, relinquish and discharge its lien on and security interest in, and right of setoff against, all of the Company’s right, title and interest in, to and under the Released Trademarks.

SECTION 3. Termination. The Administrative Agent, without any recourse, representation or warranty, hereby terminates and cancels the Trademark Security Agreement.

SECTION 4. Further Assurances. The Administrative Agent hereby authorizes the Company or the Company’s authorized representative to (i) record this Release with the USPTO, (ii) file UCC financing statement terminations with the applicable filing office in order to memorialize the release of the security interest of the Administrative Agent in the Released Trademarks and/or (iii) otherwise record or file this Release in the applicable governmental office or agency. The Administrative Agent, at the direction of the Lenders, further agrees to execute and deliver to the Company any and all further documents and instruments, and do any and all further acts which the Company (or its agents or

designees) reasonably requests (at the Company's sole cost and expense) in order to confirm this Release and the Company's right, title and interest in, to and under the Released Trademarks.

SECTION 5. Choice of Law. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.

SECTION 6. Counterparts. This Release may be executed in any number of counterparts, all of which shall constitute one and the same instrument, and any party hereto may execute this Release by signing and delivering one or more counterparts.

SECTION 7. Capacity. This Release has been signed by Cortland Capital Market Services LLC not in its individual capacity but solely in its capacity as Administrative Agent.
