RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of November 27, 2018 (the "Effective Date"), is made by JPMorgan Chase Bank, N.A., in its capacity as Collateral Agent on behalf of the Lenders (the "Agent"), in favor of the grantor party identified on the signature page hereto (the "Grantor").

WHEREAS, pursuant to that certain Collateral Agreement, dated as of April 17, 2013 by and among the Agent, the Grantor and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the "Collateral Agreement"), the Grantor granted to the Agent, in its capacity as Collateral Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Collateral Agreement, the Grantor executed and delivered a Trademark Security Agreement, dated as of April 17, 2013, and a Trademark Security Agreement, dated as of November 4, 2016 (together, the "Trademark Security Agreements"), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreements were recorded with the United States Patent and Trademark Office on April 19, 2013 and January 9, 2018 at Reel/Frame 5010/0156 and Reel/Frame 6245/0541, respectively;

WHEREAS, the Agent now desires to release any and all security interests, and any other lien, it has in the Trademark Collateral (as defined below);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. The term "Trademark Collateral" means all of Grantor's right, title and interest in, whether now owned or hereafter acquired by Grantor: (a) all Trademarks, including those listed on Schedule I attached hereto and (b) all Proceeds of any and all of the foregoing. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Collateral Agreement or the Trademark Security Agreements, as applicable.

2. Release. The Agent hereby absolutely, unconditionally and irrevocably releases, discharges, terminates and cancels, for the benefit of Grantor and its successors and assigns, all of its security interest in and to the Trademark Collateral, arising under the Collateral Agreement and the Trademark Security Agreements, and any other security interests, liens, right, title or interest that the Agent, acting in its capacity as Collateral Agent under the Collateral Agreement and the Trademark Security Agreements, may have in or to the Trademark Collateral. If and to the extent that the Agent has acquired any right, title or interest in and to the Trademark Collateral under the Collateral Agreement or the Trademark Security Agreements, the Agent, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantor.

3. Termination. The Agent acknowledges and agrees that the Collateral Agreement and the Trademark Security Agreements are terminated with respect to the Trademark Collateral.

4. Further Assurances. The Agent agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably

requested by the Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.
