RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release"), dated as of November 30, 2018, is executed by JPMORGAN CHASE BANK, N.A. WHEREAS, Lender wishes to terminate, release and forever discharge, without recourse, representation or warranty, its Security Interest in and to the Released Collateral as provided in this release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Lender hereby, without recourse, representation or warranty, terminates, releases and forever discharges all of its Security Interest in and to the Released Collateral and hereby terminates the Trademark Security Agreement and reassigns to Grantor any and all rights, title and interest it has been assigned by Grantor, if any, in the Released Collateral. Lender acknowledges that this Release may be filed along with any other necessary documentation with the USPTO or any other governmental office to evidence the release granted herein at the sole expense of Grantor. Lender hereby authorizes Grantor to record this Release with the USPTO and other applicable registry at the sole expense of Grantor and agrees to provide Grantor with any information and additional authorization necessary to effect the release of the Security Interest in the Released Collateral.
