**ASSIGNMENT OF SECOND LIEN
SECURITY AGREEMENT**

This **ASSIGNMENT OF SECOND LIEN SECURITY AGREEMENT** (this “Assignment”), dated as of December 12, 2018, is by **GOLDMAN SACHS BANK USA** (“GOLDMAN”), acting in its capacity as the current and resigning administrative agent and collateral agent (in such capacities, the “Resigning Agent”) and **WILMINGTON TRUST, NATIONAL ASSOCIATION** (“Wilmington”), acting in its capacity as the successor administrative agent and collateral agent (in such capacities, the “Successor Agent”).

R E C I T A L S:

WHEREAS, FullBeauty Brands, L.P., a Delaware limited partnership, Jessica London, Inc., a Delaware corporation, Swimsuits For All, LLC, a Delaware limited liability company and FullBeauty Brands Operations, LLC (f/k/a FullBeauty Brands, L.P.), a Indiana limited liability company, individually as a “Grantor”, and collectively as “Grantors” and Resigning Agent are party to that certain Second Lien Security Agreement identified on Exhibit A hereto (as the same have been and may hereafter be amended, restated, supplemented or otherwise modified from time to time, the “Agreement”), covering certain intellectual property set forth on Exhibit B attached hereto; and

WHEREAS, pursuant to that certain Notice of Resignation and Direction of Appointment of Successor Administrative Agent and Collateral Agent, dated as of the date hereof, by and among Goldman, as the Resigning Agent, Wilmington, as Successor Agent, Blackdog Holdings, Inc. (“Holdings”), FullBeauty Brands Holdings, Corp. and certain other loan parties (the “Resignation Agreement”), Resigning Agent has assigned to Successor Agent all of its rights, remedies, duties and other obligations under, among other documents, the Agreement, in each instance, in its capacities as administrative agent and collateral agent.

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Resigning Agent hereby, subject to the Resignation Agreement, the terms of which are incorporated herein by reference, assigns and transfers to Successor Agent and its successors and assigns, all of its rights, title and interest in and to and arising under the Agreement.

This Assignment may be executed in any number of counterparts, each of which when so executed shall be deemed an original and all of which taken together shall constitute one and the same instrument.

Wilmington is entering into this Assignment solely in its capacity as Successor Agent and not in its individual or corporate capacity. In acting hereunder, the Successor Agent shall be entitled to all of the rights, privileges and immunities set forth in the Credit Agreement, the Agreement and the other Loan Documents (as defined in the Credit Agreement), as though fully set forth herein.


