("Release"), dated as of the 17th day of December 2018, by **JPMORGAN CHASE BANK, N.A.**, a New York Corporation ("JPMCB"), having an office at 695 Route 46 West, Suite 101, Fairfield, NJ 07004 and **MWW Group LLC**, a Delaware limited liability company ("MWWG") having an address at One Meadowlands Plaza, East Rutherford, NJ 07073.

WITNESSETH:

WHEREAS, pursuant to the parties' February 28, 2011 Trademark Security Agreement ("Security Agreement"), MWWG granted to JPMCB a Security Interest ("Security Interest") in certain collateral as defined in said Trademark Security Agreement, including the U.S. trademark applications and registrations listed in Exhibit A ("Trademarks") hereto:

WHEREAS, the Security Interest was recorded in the United States Patent and Trademark Office at reel/frame 004488/0768; and

WHEREAS, MWWG and JPMCB have agreed to retire the parties' obligations under the Security Agreement and JPMCB wishes to release its Security Interest in the U.S. trademark applications and registrations listed in Exhibit A hereto;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. JPMCB hereby releases its Security Interest and any right, title and interest which it may have in and to the Trademarks listed on Exhibit A hereto, does hereby release and terminate all liens and security interests in and to the Trademark

collateral which were granted, pledged and assigned to JPMCB, including the right to sue for past, present and future infringements thereof.

2. This Release may be filed by MWWG with the United States Patent and Trademark Office without further notice.


