**TERMINATION AND RELEASE  
OF GRANT OF SECURITY INTEREST (TRADEMARKS)**

**TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST (TRADEMARKS)** (this "Release"), dated as of December 10, 2018, by **WEBSTER BANK, NATIONAL ASSOCIATION** (the "Agent"), in favor of **HANLEY WOOD MEDIA, INC.**, a Delaware corporation (the "Grantor").

**WHEREAS**, pursuant to the terms of that certain Grant of Security Interest (Trademarks), dated as of June 9, 2015 (the "Trademark Security Agreement"), by the Grantor in favor of the Agent, the Grantor granted to the Agent a security interest in and to the following property of the Grantor, now owned or hereafter acquired by the Grantor (collectively, the "Collateral"):

- (a) trademarks and registrations thereof, including the trademarks listed on Schedule 1 (collectively, the "Trademarks");
- (b) the goodwill of the business symbolized by the Trademarks; and
- (c) all proceeds thereof, including, without limitation, from any and all causes of action which may exist by reason of infringement thereof.

**WHEREAS**, the Agent wishes to terminate and release its security interests in and to all of the right, title and interest of the Grantor in and to the Collateral; and

**WHEREAS**, the Trademark Security Agreement was filed on January 29, 2016 with the United States Patent and Trademark Office in Reel: 005719; Frame: 0323.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby automatically terminates, releases and discharges fully its security interests in and to all of the right, title and interest of the Grantor in and to the Collateral, as granted under the Trademark Security Agreement, and reassigns and transfers to the Grantor all right, title and interest that the Agent may have in the Collateral, and terminates the Trademark Security Agreement. The Agent hereby authorizes the Grantor, or the Grantor's authorized representative or designee, to record this Release with the United States Patent and Trademark Office.
