## TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENTS

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENTS** (this “*Termination and Release*”) is granted as of October 5, 2018 by SANTANDER BANK, N.A. (f/k/a SOVEREIGN BANK), as Agent and Lender (the “*Agent*”), in favor of EAST COAST SEAFOOD, LLC, a Massachusetts limited liability company (the “*Borrower*”),

**WHEREAS**, the Borrower executed and delivered a Trademark Assignment of Security dated as of January 12, 2012 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*2012 Agreement*”), granting the Agent a security interest in and lien on certain trademarks and trademark applications (“*Marks*”) described therein, which was recorded with the United States Patent and Trademark Office (“*USPTO*”) on January 24, 2012, at Reel 4703, Frame 0643;

**WHEREAS**, Borrower executed and delivered a Trademark Assignment of Security dated as of August 21, 2015 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*2015 Agreement*”), granting the Agent a security interest in and lien on certain Marks described therein, which was recorded with the USPTO on August 26, 2015, at Reel 5608, Frame 0815;

**WHEREAS**, the Borrower has requested that the Agent hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Borrower in, to and under all of the Marks (as defined in the 2012 Agreement and the 2015 Agreement, respectively) (collectively, the “*Trademark Collateral*”) as herein provided; and

**WHEREAS**, the Borrower has requested that the Agent provide a document suitable for recording with the USPTO to evidence the release of the Agent’s security interests in and liens on the Trademark Collateral as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby:

1. terminates the grants and releases, terminates and discharges all liens and security interests in the Borrower’s right, title and interest in, to and under the Trademark Collateral, and all goodwill associated therewith, including those trademarks and trademark applications identified in Schedule A hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.




