**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (the “Release”) is made as of December 28, 2018, by **SEACOAST CAPITAL PARTNERS IV, L.P.**, a Delaware limited partnership (the “Purchaser”) in favor of **ON-NET SURVEILLANCE SYSTEMS INC.**, a New York corporation (the “Grantor”).

WITNESSETH

WHEREAS, pursuant to (i) that certain Trademark Security Agreement, dated as of June 28, 2017, by and between the Grantor and the Purchaser (as heretofore amended, restated, supplemented or otherwise modified, the “Trademark Security Agreement”; all capitalized terms used herein but not otherwise defined shall have the meanings set forth in the Trademark Security Agreement), the Grantor unconditionally granted, assigned, and pledged to the Purchaser a continuing security interest in all of such Grantor’s right, title and interest in and to the Trademark Collateral, including the trademarks identified on Schedule A attached hereto (the “Trademark Security Interest”);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on June 29, 2017 at Reel 6095, Frame 163;

WHEREAS, the Grantor has satisfied in full the terms of the Purchase Agreement and Trademark Security Agreement and requests a release of the Trademark Security Interest; and

WHEREAS, the Purchaser desires to terminate and grant a release of the Trademark Security Interest as provided in this Release.

NOW THEREFORE, for good and valuable consideration tendered by the Grantor, the receipt and sufficiency of which are hereby acknowledged, the Purchaser does hereby agree as follows:

1. The Purchaser hereby (a) terminates the Trademark Security Agreement, (b) releases, relinquishes, terminates and discharges the Trademark Security Interest in its entirety and (c) reassigns to the Grantor any and all right, title and interest of any nature whatsoever which it may hold in or to the any of the Trademark Collateral (including, without limitation, the trademarks identified on Schedule A attached hereto) and associated common law rights and goodwill appurtenant thereto.
2. The Purchaser authorizes the United States Patent and Trademark Office and any other applicable governmental authority to record this Release.
3. At the request and sole expense of the Grantor, the Purchaser agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions necessary to carry out the purposes of this Release.
