## RELEASE OF SECURITY INTEREST IN TRADEMARKS

RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this “**Release**”) dated as of November 1, 2018 between Mustang Acquisition Holdings, Inc. (the “**Grantor**”), and Canadian Imperial Bank of Commerce, as administrative agent for the Secured Parties (in such capacity, the “**Administrative Agent**”).

### RECITALS

- (A) Pursuant to a Notice of Grant of Security Interests in Trademarks, dated as of December 31, 2016 (the “**Agreement**”; capitalized terms used but not otherwise defined herein have the meanings specified in the Agreement) between the Grantor and the Administrative Agent, which Agreement was recorded in the US Trademark Office on June 28, 2017, at Reel 6092, Frame 0748, the Grantor has granted a security interest in its right, title and interest in the Intellectual Property Collateral to the Administrative Agent, for the benefit of the Secured Parties.
- (B) The Administrative Agent (acting on behalf of the Secured Parties) has agreed to release the security interests created under the Agreement in the Intellectual Property Collateral, which is listed in Schedule 1, on the terms and conditions set forth in the Global Release of Security dated as of October 2, 2018, among the Administrative Agent, the Grantor and certain other parties thereto.


**NOW, THEREFORE**, in consideration of the foregoing and for other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent (acting on behalf of the Secured Parties) hereby releases the security interests over the Intellectual Property Collateral created by the Agreement as of the date first written above.

This Release shall be governed by and construed in accordance with the laws of the State of New York (including, without limitation, Section 5-1401 of the General Obligations Law of the State of New York), without regard to conflict of laws principles that would require application of another law. This Release will be binding upon and inure to the benefit of each party and its successors and assigns.
