RELEASE OF SECURITY AGREEMENT

THIS RELEASE dated as of **November 13, 2018** (this "Release") is made by U.S. Bank National Association, a National Association, acting in its capacity as secured party (in such capacity, the "Secured Party") under that certain **PATENT AND TRADEMARK SECURITY AGREEMENT**, dated as of **March 29, 2013** and recorded **04/24/2013 Reel 5013 Frame 0470** in the records of the United States Patent and Trademark Office (as amended, supplemented or modified and in effect from time to time, the "Security Agreement"), among **GL Group, Inc.**, (the "Debtor") and the Secured Party;


