TRADEMARK ASSIGNMENT AGREEMENT

WHEREAS, SafePro, L.P., having offices at 1355 North Walton Walker Blvd., Dallas, Texas, 75211-1042, a limited partnership organized under the laws of the State of Texas ("SAFEPRO"), owns, by assignment, all right, title, and interest in the Domestic and Foreign Trademark Rights identified in Schedule I attached hereto, together with the associated goodwill inherent therein; and Rooftop Anchor, Inc., having offices at 844 South 430 West, Suite 200, Heber City, Utah, 84032, a corporation organized under the laws of the State of Utah (RTA), desires to own SAFEPRO's entire right, title, and interest in and to the Domestic and Foreign Trademark Rights identified in Schedule I attached hereto, in all countries throughout the world;

WHEREAS, SAFEPRO owns the entire right, title and interest in and to certain U.S. and foreign trademarks and services marks, both registered and unregistered, and applications for trademark and service mark registrations filed with the United States Trademark Office and foreign trademark applications, as listed in Schedule I attached hereto (collectively the Marks);

WHEREAS RTA desires to acquire all of SAFEPRO's right, title and interest, in and to the Marks together with all the goodwill of the business symbolized thereby, and SAFEPRO desires to assign all such right, title and interest in and to the Marks to RTA, upon the terms and conditions set forth herein.

NOW, THEREFORE, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged by SAFEPRO, the parties agree as follows:

1. SAFEPRO hereby conveys and assigns to RTA, and RTA hereby accepts from SAFEPRO, all of SAFEPRO's right, title and interest in and to the Marks, together with the goodwill of the business symbolized by the Marks, and the right to bring suit and recover damages for past infringement thereof.
2. SAFEPRO represents and warrants that:
 - (i) SAFEPRO owns the entire right, title and interest in and to the Marks;
 - (ii) all registrations for the Marks are currently valid and subsisting and in full force and effect;
 - (iii) SAFEPRO has not licensed the Marks to any other person or entity or granted, either expressly or impliedly, any trademark or servicemark rights with respect to the Marks to any other person or entity;
 - (iv) there are no liens or security interests against the Marks;
 - (v) SAFEPRO has all authority necessary to enter into this Trademark Assignment Agreement (TM Agreement) and the execution and delivery of this TM Agreement has been duly and validly authorized; and
 - (vi) execution of this Assignment and performance of SAFEPRO's obligations hereunder shall not violate or conflict with any other TM Agreement to which SAFEPRO is a party or provision of SAFEPRO's Certificate of Incorporation or By-laws.
