**RECITAL[S]**

- 2.2 Assignor agrees and undertakes to provide Assignee with all reasonable assistance with any proceedings which may be brought by or against Assignee against or by any third party in relation to the Trade Marks.


**3. FURTHER ASSURANCE**


4. **LAW AND JURISDICTION**

This Agreement will be governed by the law in force from time to time in England and Wales and the parties consent to the jurisdiction of the Courts of England and Wales.


