1. **Assignment.** Assignor confirms the assignment of the Trademark from Assignor to Assignee set forth in the Original Assignment, and as such hereby assigns to Assignee, and Assignee hereby accepts, the assignment and ownership of the full right and title to and in the Trademark, together with the goodwill of the business concerned in the services for which the Trademark is used.
2. **Further Actions.** Assignor and Assignee each agree to take any further steps necessary and appropriate to confirm and fully effectuate the assignment of the Trademark from Assignor to Assignee.
3. **Recordal.** Assignee and Assignor each agree that this Assignment shall be recorded with the USPTO as may be necessary and appropriate to fully effectuate Assignor's assignment of the Trademarks to Assignee and allow Assignee to maintain the Trademark registration.
4. **Right to Defend and Enforce.** This Assignment includes the rights to Assignee, as may be necessary and/or appropriate, to take any and all actions necessary to defend, protect and enforce Assignee's rights and ownership in and to the Trademark.




