IP ASSIGNMENT

This IP ASSIGNMENT (the “Assignment”) is made and entered into as of January 7, 2019 (the “Effective Date”) by and among THE ARTS INSTITUTES INTERNATIONAL, LLC, an Arizona not-for-profit limited liability company (“AII”) on the one hand, and DREAM CENTER EDUCATION HOLDINGS, LLC, an Arizona not-for-profit limited liability company (“DCEH”) and DREAM CENTER EDUCATION MANAGEMENT, LLC, an Arizona not-for-profit limited liability company (“DCEM” and together with DCEH the “Dream Parties”) on the other hand. Each of AII and the Dream Parties may be referred to herein individually as a “Party” and collectively as the “Parties”.

WHEREAS, the Parties entered into a Framework Agreement between the Parties and certain other entities dated December 22, 2018, which the Parties and certain other entities amended and restated as of the Effective Date (the “Amended and Restated Framework Agreement”);

WHEREAS, the Dream Parties currently own certain Intellectual Property Rights that are used by certain university systems operated by AII (the “Ai University System”) and the Parties desire that such Intellectual Property Rights be assigned to AII;

WHEREAS, the Dream Parties have retained certain campuses and the Ai Online division and for purposes of a teach out of those campuses and the Ai Online division, the Parties are separately entering into that certain License Agreement as of the Effective Date (the “License Agreement”), pursuant to which AII is providing a grant-back license of certain Intellectual Property Rights that are the subject of this Assignment and such separate License Agreement is a material inducement for the Dream Parties to enter into this Assignment; and

NOW, THEREFORE, in consideration of the mutual covenants, agreements and understandings contained herein, and for other good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, the Parties hereby agree as follows:

1. **Definitions.** Capitalized terms used but not otherwise defined herein have the meanings ascribed to such terms in the Amended and Restated Framework Agreement.

(a) “AI Online Curricular Know-How” means Curricular Know-How that is on the Effective Date used in and necessary for the conduct of the business of Ai Pittsburgh for its Ai Online division.

(b) “AI Online Curricular Materials” means Curricular Materials that are on the Effective Date used in and necessary for the conduct of the business of Ai Pittsburgh for its Ai Online division.

(c) “Affiliate” means, with respect to any Person, any other Person directly or indirectly through one or more intermediaries controlling, controlled by or under common control with such other Person. For purposes of the immediately preceding sentence, the term “control” (including, with correlative meanings, the terms “controlling,” “controlled by” and “under common control with”), as used with respect to any Person, means the possession, directly or indirectly, of the power to direct or cause the direction of the management and

policies of such Person, whether through ownership of voting securities, by contract or otherwise.

(a) “Business” means the business of the Ai University System as it is currently conducted.

(b) “Curricular Know-How” means all know-how, information and trade secrets that is reasonably necessary, sufficient or helpful to enable the Ai University System or their designees to Use (as defined below) the Curricular Materials developed before the Effective Date.

(c) “Curricular Materials” means all (a) educational materials, media and tools and (b) other resources that provide educational, curriculum, instructional and research experiences for students, in each case ((a) and (b)) in whatever format (including written, verbal, electronic, auditory, visual, tactile or otherwise) and developed before the Effective Date, that are used in, held for use in, or necessary for the operation of the Business, and including the following: lesson plans and planning materials; syllabi; textbooks; know-how; workbooks; manipulatives; charts; graphs; pictorials; posters; learning standards or objectives; lesson objectives; assignments and projects given to students; books, materials, videos, presentations, and readings used in a course; and the tests, assessments, and other methods used to evaluate student learning.

(d) “Governmental Authority” means any government, any governmental or regulatory entity or body, department, commission, board, agency or instrumentality, and any court, tribunal or judicial body, in each case whether federal, state, county, provincial, and whether local or foreign.

(e) “Intellectual Property Rights” means any and all of the following in any jurisdiction throughout the world: (i) all inventions (whether or not patentable or reduced to practice), patents, patent applications and patent disclosures as well as any reissues, continuations, continuations-in-part, divisionals, revisions, extensions or reexaminations thereof (collectively, “Inventions”), (ii) trademarks, service marks, trade dress, trade names, slogans, designs, logos, internet domain names, corporate names and all other indicia of origin (and all translations, adaptations, derivations, and combinations of the foregoing), together with all of the goodwill associated with the foregoing (collectively, “Marks”), (iii) all copyrights and other works of authorship, mask works and moral rights, (collectively, “Copyrights”) (iv) registrations, applications and renewals for any of the foregoing (as applicable), (v) computer software (including source code and object code), data, data bases and documentation thereof, (vi) trade secrets and other confidential information (including ideas, formulas, compositions, inventions, know-how, manufacturing and production and other processes, techniques and methods, research and development information, drawings, specifications, designs, plans, proposals, technical data, business and marketing plans and customer and supplier lists and related information), (collectively, “Trade Secrets”), (vii) all other intellectual property and proprietary rights and (viii) all tangible embodiments of the foregoing (in whatever form or medium).

(f) “Person” means an individual, corporation, partnership, association, limited liability company, trust, estate or other similar business entity or organization, including a Governmental Authority.

2. Assignment. The Dream Parties hereby (on behalf of themselves and their Affiliates) absolutely and irrevocably sell, transfer, assign, convey, and deliver to AII, and AII (on behalf of itself and the Ai University System) hereby accepts, all right, title and interest in and to:

(a) the (i) Marks (including the domain names) and social media accounts set forth on Schedule A, and any other Marks or social media accounts that are or were used in, held for use in, or necessary for the operation of the Business, and (ii) all applications, registrations, issuances, renewals, and extensions which are or may be secured under applicable law for any of the foregoing items in (i), ((i) and (ii), the “AII Transferred Marks”), including for the avoidance of doubt all goodwill of the Business connected with the use of, and symbolized by, such AII Transferred Marks, but, excluding, for the avoidance of doubt, any and all rights to the words “Dream Center” (except that it is recognized that AII may make some use of these words as part of its transition away from the Dream Parties’ involvement in the Ai University System provided that such use is consistent with past use prior to the Effective Date);

(b) all (i) Copyrights, (ii) copyright registrations, (iii) applications for copyright registration, (iv) exclusive copyright licenses, and (v) copyrightable works in each case that are or were used in, held for use in, or necessary for the operation of the Business ((i)-(v), the “AII Transferred Copyrights”), including those set forth on Schedule B and those contained in the Curricular Materials, but excluding in all cases the AI Online Curricular Materials;

(c) All Trade Secrets that are or were used in, held for use in, or necessary for the operation of the Business (the “AII Transferred Trade Secrets”), including all Curricular Know-How (but excluding the AI Online Curricular Know-How);

(d) All Inventions that are or were used in, held for use in, or necessary for the operation of the Business, including those set forth on Schedule C;

(e) Any other Intellectual Property Rights that are or were used in, held for use in, or necessary for the operation of the Business (including everything set forth on Schedule E, attached hereto and incorporated herein by reference), but excluding (i) all Shared IT Systems (as defined in the Amended and Restated Framework Agreement), for avoidance of doubt, (ii) any computer software constituting Shared IT Systems that is licensed by the Dream Parties from third parties which are not Affiliates of the Dream Parties, and, for the avoidance of doubt, (iii) any and all rights to the words “Dream Center”;

(f) Any common law rights or other rights of any kind whatsoever accruing under the AII Transferred Marks, the AII Transferred Copyrights, or other Intellectual Property Rights transferred pursuant to Sections 2(a)-(e), provided in each case by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world;

(g) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing in Sections 2(a)-(f);

(h) any and all claims and causes of action with respect to any of the foregoing in Sections 2(a)-(g), whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief, to collect, or otherwise recover, any such damages, and to bring any proceeding in the United States Patent and Trademark Office or any equivalent agency in any other country for cancellation or opposition or other proceedings in connection with any of the foregoing in Sections 2(a)-(g), (all of the foregoing in Sections 2(a)-(h), "AII Transferred IP"). For avoidance of doubt, AII Transferred IP shall not include Shared IT Systems, all of which is listed in Schedules 2.19(a) to the Amended and Restated Framework Agreement.

3. Intent to Use. With respect to any AII Transferred Marks that are the subject of intent-to-use applications, AII represents, warrants and covenants that AII and its Affiliates are the successors to the Business and that such Business is ongoing and existing.

4. Representations and Warranties. The Dream Parties represent and warrant that the AII Transferred IP is free and clear of all Liens. Except as set forth on Schedule D, the Dream Parties are not aware of any reason why the AII Transferred IP cannot be assigned to AII. To the extent any of the AII Transferred IP cannot, as of the Effective Date, be assigned under applicable law pursuant to this Assignment, (a) the Dream Parties shall not (and will ensure that each of their Affiliates do not) sell, transfer, assign, convey, or deliver to any third party or register or use in any manner (except to take necessary steps to obtain registration of unassignable AII Transferred IP) unassignable AII Transferred IP or otherwise dispute or challenge AII's or its assignees' sale, transfer, assignment, conveyance, delivery, registration or use of such unassignable AII Transferred IP; and (b) the Dream Parties, on behalf of themselves and their respective Affiliates, hereby grant AII an exclusive (except with respect only to the grant-back license provided in the License Agreement), royalty-free, transferable, irrevocable, worldwide, fully paid-up license (with rights to sublicense through multiple tiers of sublicensees) to fully use, and, to the extent the Dream Parties or their Affiliates hold such rights in the unassignable IP, to reproduce, prepare derivative works of, distribute, publicly perform, publicly display, practice, transmit, make, use, offer to sell, sell, import, and otherwise exploit ("Use") such unassignable AII Transferred IP. To the extent any of the AII Transferred IP cannot, as of the Effective Date, be assigned or licensed under applicable law pursuant to this Assignment, then the Dream Parties, on behalf of themselves and their respective Affiliates, hereby to the maximum extent permitted by law irrevocably waive and agree never to assert the unassignable and non-licensable rights, title and interest against AII or the Ai University System or any of the AII's Affiliates, successors in interest, or customers or other designees (including, without limitation, any moral rights). In the event any such unassignable AII Transferred IP is subsequently assignable, the Dream Parties shall promptly take all necessary action (and shall cause each of their Affiliates to take all necessary action) to assign such AII Transferred IP to AII.

5. Recordation; Further Assurances. The Dream Parties hereby authorize the Commissioner for Trademarks in the United States Patent and Trademark Office, the Register of Copyrights in the United States Copyright Office, and the officials of corresponding entities or agencies in any applicable jurisdictions, to record and register this Assignment upon request by

AII. The Dream Parties further agree that they will (and will cause each of their Affiliates to) promptly execute, verify, acknowledge and deliver all such further papers, including any instruments of transfer and recordable assignments, and perform such other acts as AII lawfully may request from time to time, to perfect and vest title in the AII Transferred IP in AII, or AII's successors and assigns, provided that all reasonable and necessary out of pocket expenses associated with any of the foregoing actions shall be borne by AII. Upon AII's request, the Dream Parties will, and will ensure that their Affiliates and each of their respective employees, agents, subcontractors and contractors will, as soon as practicable, provide to AII (or the Ai University System) a copy of all of the Curricular Materials and an embodiment of all of the Curricular Know-How, and an embodiment of any other AII Transferred IP, in a reasonable format requested by AII or the Ai University System, as necessary to enable AII and the Ai University System to fully Use the AII Transferred IP. The Dream Parties shall provide (and shall cause their Affiliates to provide) training on all Uses which the Dream Parties or any of their Affiliates have made of the AII Transferred IP at such reasonable times and locations as AII and the Ai University System reasonably request so that AII and the Ai University System and their designees are sufficiently informed and instructed on how to make Use of the AII Transferred IP.

6. Domain Name Assignment; Administrative Rights. Promptly following the Effective Date, the Dream Parties shall (and shall, if necessary, cause their Affiliates to), at AII's cost and expense, deliver to the domain name registrar of each domain name set forth on Schedule A hereto such duly and validly executed documents and instruments, or take such other actions, as may be required by such registrar to designate AII, or its designees, as the sole administrative contact and technical contact with respect to such domain name. As soon as reasonably practicable, the Dream Parties will ensure that AII and its designees have full and unencumbered access to and administrative rights with respect to all the social media accounts including in the AII Transferred IP, including the Facebook page for the Specified Campuses and the national AI Page, located at <https://www.artinstitutes.edu/> (the "National AI Page"), and that, until such time as such access to and administrator rights have been conveyed, the Dream Parties' personnel will work closely with AII's or its designee's personnel to ensure that AII has the ability to implement any marketing strategies involving such social media accounts, including Facebook pages and the National AI Page.

7. Governing Law; Jurisdiction and Venue; Waiver of Jury Trial.

(a) This Assignment, and all proceedings or counterclaims (whether based on contract, tort or otherwise) arising out of or relating to this Assignment or the actions of the Parties hereto in the negotiation, administration, performance and enforcement hereof, shall be governed by and construed in accordance with the internal substantive laws of the State of Delaware, without giving effect to any choice or conflict of laws provision or rule (whether of the State of Delaware or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than the State of Delaware.

(b) Each of the Parties hereto submits to the exclusive jurisdiction and venue of the Delaware Chancery Courts located in Wilmington, Delaware, or, if such court shall not have jurisdiction, any state or federal court sitting in Wilmington, Delaware, in any action or proceeding arising out of or relating to this Assignment and agrees that all claims in respect of

the action or proceedings may be heard and determined in any such court and hereby expressly submits to the personal jurisdiction and venue of such court for the purposes hereof and expressly waives any claim of improper venue and any claim that such courts are an inconvenient forum. Each of the Parties hereto hereby irrevocably consents to the service of process of any of the aforementioned courts in any such suit, action or proceeding by the mailing of copies thereof by registered or certified mail, postage prepaid, to its address set forth in Section 8.2 of the Amended and Restated Framework Agreement, such service to become effective ten (10) days after such mailing.

(c) EACH OF THE PARTIES HERETO WAIVES ANY RIGHT IT MAY HAVE TO TRIAL BY JURY IN RESPECT OF ANY LITIGATION BASED ON, ARISING OUT OF, UNDER OR IN CONNECTION WITH THIS ASSIGNMENT, OR ANY COURSE OF CONDUCT, COURSE OF DEALING, VERBAL OR WRITTEN STATEMENT OR ACTION OF ANY PARTY HERETO.

8. Assignment. Neither Party will assign (by operation of law or otherwise) any right or obligation under this Assignment without the other Party's prior written consent; *provided, however,* that the foregoing restriction shall not limit the sublicense, assignment, or other transferability of specific rights and licenses granted to AII and the Ai University System as expressly stated in this Assignment. Any attempted assignment in violation of the foregoing will be void. Subject to the foregoing, this Assignment will be binding upon and will inure to the benefit of the Parties' respective successors and permitted assigns, including any change pursuant to the proposed restructure that would result in a new branch/main designation and a new Office of Postsecondary Education Identification number (OPEID). Notwithstanding the foregoing, (a) in the event that AII establishes an Affiliate that would benefit from the AII Transferred IP hereunder, AII may assign this Assignment to such Affiliate or Subsidiary, (b) AII may assign this Assignment as collateral to its financing sources and (c) AII may assign this Assignment in connection with a Change of Control of AII or any of its Affiliates.

9. Authorization. Each Party represents that it has taken all necessary action to authorize the execution and delivery of this Assignment.

10. Counterparts. This Agreement may be executed in one or more counterparts, all of which shall be considered one and the same agreement and shall become effective when one or more counterparts have been signed by each of the Parties and delivered to the other party, it being understood that all Parties need not sign the same counterpart. Delivery of an executed counterpart of a signature page to this Agreement by facsimile transmission or by E-mail of a .pdf attachment shall be effective as delivery of a manually executed counterpart of this Agreement.

11. Obligations. All obligations of each of the Dream Parties under this Assignment are joint and several. In the event that any provision of this Agreement, or the application thereof, becomes or is declared by a court of competent jurisdiction to be illegal, void or unenforceable, the remainder of this Agreement will continue in full force and effect and the application of such provision to other persons or circumstances will be interpreted so as reasonably to effect the intent of the Parties hereto. The Parties further agree to replace such void or unenforceable provision of this Agreement with a valid and enforceable provision that

will achieve, to the extent possible, the economic, business and other purposes of such void or unenforceable provision.

12. Rules of Construction. Unless otherwise indicated, the words “include,” “includes” and “including,” when used herein, shall be deemed in each case to be followed by the words “without limitation” and unless the context requires otherwise, “or” shall be construed in the inclusive sense (to mean “and/or”).

13. Third Party Beneficiaries. The Affiliates of AII that operate the Ai University System are third party beneficiaries of this Assignment (other than AII, which is a Party).

14. Schedules. Within five (5) business days of the Effective Date either Party may provide to the other Party proposed corrections to any of the Schedules to this Assignment, with supporting documentation. The other Party will be under no obligation to accept such proposal unless it is clear from the supporting documentation that the Schedule contains an error. In the event of any disagreement concerning any proposed corrections, the disagreement shall be escalated for resolution between a Studio executive and a DCEH executive. If the disagreement cannot be resolved the Schedule will remain unchanged. Any agreed corrections will be documented in an amended Assignment.
