NUNC PRO TUNC TRADEMARK ASSIGNMENT

This Trademark Assignment is entered into by and between Ashley Boeckle, a United States citizen with a mailing address at 1009 Somerton Drive, Costa Mesa, California 92627 (“Assignor”) and Spudsy, LLC a California limited liability company with a mailing address at 1009 Somerton Drive, Costa Mesa, California 92627 (“Assignee”).

WHEREAS, Assignor intended to use in commerce the trademark SPUDSY in connection with food products (the “Mark”), and on March 30, 2018, filed an application with the U.S. Patent and Trademark Office, assigned Serial No. 87857085, indicating that intention for “prepared foods, packaged foods, pasta, bread, flat bread, pizza crust, cereal, tortillas, crackers, rice puffs, rice cakes, oatmeal, protein bars, foods made primarily from sweet potatoes”, but has not yet filed an allegation of use under § 1(c) or (d) of the Trademark Act;

WHEREAS, Assignor has sold, transferred and assigned the Mark and corresponding goodwill as part of the sale of that portion of Assignor’s business to which the Mark pertains as required by 15 U.S.C. § 1060;

WHEREAS, Assignee purchased that portion of Assignor’s business to which the Mark pertains, acquired said Mark and goodwill, the pending intent to use U.S. trademark application therefor, and now desires to confirm the Assignment of the Mark for purposes of filing the same with the United States Patent and Trademark Office (the "PTO");

NOW, THEREFORE, for good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, Assignor does hereby confirm assignment to Assignee of all right, title and interest in and to the SPUDSY trademark, together with the goodwill of the business symbolized thereby, the U.S. application therefore, and all rights to proceeds of the foregoing, including, without limitation, any claim by Assignor against third parties for past, present, or future infringement of the Mark nunc pro tunc and effective as of May 18, 2018.
