**TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (SECOND SUPPLEMENT)**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (SECOND SUPPLEMENT) is made as of October 26, 2018 in favor of the grantors listed on Schedule I hereto (each a "Grantor," and collectively the "Grantors") by Barclays Bank PLC, as Collateral Agent (the "Collateral Agent"). Capitalized terms not defined herein shall have the meanings ascribed to them in the Second Supplemental IP Security Agreement (as defined below).

WHEREAS, pursuant to that certain Supplement No. 2 to the April 2, 2007 Intellectual Property Security Agreement, which Supplement was dated as of December 23, 2009, by and among Grantors and the Collateral Agent (the "Second Supplemental IP Security Agreement"), each Grantor created and granted to the Collateral Agent and its successors and assigns, for the benefit of the Secured Parties and their successors and assigns, a security interest in and lien on all of such Grantor's right, title and interest in and to the Collateral of such Grantor, including the Intellectual Property of such Grantor set forth on Schedule II hereto (collectively, the "IP Collateral");


WHEREAS, the Second Supplemental IP Security Agreement was recorded with the United States Copyright Office on January 27, 2010 at Volume 3586, Doc No. 266 (with respect to copyrights), and was recorded with the United States Patent and Trademark Office on February 11, 2010 at Reel/Frame 4147/0400 (with respect to trademarks);

WHEREAS, the Collateral Agent wishes to release its security interest in and lien on the IP Collateral and reassign to each Grantor any right, title or interest that the Collateral Agent may have in the IP Collateral of such Grantor.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates the Second Supplemental IP Security Agreement and hereby terminates, cancels and releases its security interest in and lien on the IP Collateral, and reassigns to each Grantor any right, title or interest it may have in the IP Collateral of such Grantor.
