2. Article 1 of the Articles of Incorporation of this corporation is amended to read as follows:

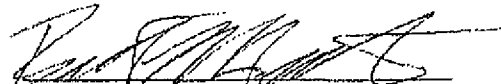
The name of this corporation is **Newport Business Media.**
