RELEASE OF SECURITY INTEREST

This RELEASE OF SECURITY INTEREST (this "Release"), dated as of November 9, 2018, is executed by Löwen Watch Group, Inc., a Utah corporation ("Löwen"), in favor of The Hurlingham Polo Association, a private company of the United Kingdom ("HPA").

RECITALS

A. Pursuant to the Purchase, Sale, and Settlement Agreement dated as of November 14, 2017 between the Parties (the "Purchase Agreement"), Löwen agreed to take as consideration for the sale and assignment to HPA of the mark HURLINGHAM for watches (the "HURLINGHAM Mark"), the associated goodwill symbolized thereby, and U.S. Trademark Registration No. 3,797,268 for the HURLINGHAM Mark in International Class 14 for watches (the "HURLINGHAM Registration") the payment of a sum of money partially over time (the "Secured Obligation").

B. As a result, pursuant to the Purchase Agreement, HPA was required to execute and deliver to Löwen a Trademark Security Agreement to secure payment of the Secured Obligation. HPA duly executed and delivered the Trademark Security Agreement to Löwen.

C. On December 1, 2017, Löwen submitted a copy of the Trademark Security Agreement to the United States Patent and Trademark Office ("PTO") for recordation with respect to the HURLINGHAM Mark, the associated goodwill symbolized thereby, and the HURLINGHAM Registration for watches in the United States (collectively, the "Trademark Collateral"), and the PTO duly recorded the Trademark Security Agreement at Reel 006218 and Frame 0520.

D. On November 9, 2018, HPA paid to Löwen the remaining sum of money that HPA owed to Löwen under the Purchase Agreement and satisfied the Security Obligation. Accordingly, Löwen is required to release its lien and security interest in and to the Trademark Collateral.

RELEASE


1. **Release.** In view of the above Recitals, Löwen hereby releases and forever discharges any and all liens and security interests that Löwen holds against the Trademark Collateral, including without limitation U.S. Trademark Registration No. 3,797,268 for the HURLINGHAM Mark.

2. **Further Assurances.** Löwen agrees to take any and all other actions reasonably requested by HPA or in furtherance of the releases granted in paragraph 1 above, including, without limitation, executing and delivering such additional documents and instruments, if any, as may be reasonably necessary or appropriate to release such liens and security interests.
