TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT, dated as of January 22, 2019 (this "Agreement"), is made by **LEESA SLEEP, LLC**, a Delaware limited liability company, 3200 Pacific Avenue, Virginia Beach, Virginia 23451 ("Grantor"), in favor of **PETER M. GRAHAM**, c/o One Better Ventures II, LLC, 1122 Oberlin Road, Raleigh, North Carolina 27605, as the agent for the Noteholders (as defined in the Security Agreement, as hereinafter defined) (together with his successor(s) and assigns thereto in such capacity, the "Agent").

W I T N E S S E T H:

WHEREAS, Grantor has entered into a Security Agreement dated as of the date of this Agreement with Agent (as amended, supplemented, restated or otherwise modified from time to time, the "Security Agreement"), pursuant to which Grantor has granted a security interest in favor of Agent, as the agent for the Noteholders, in the assets of Grantor more particularly described in the Security Agreement to secure payment of the Obligations (as defined in the Security Agreement); and

WHEREAS, pursuant to the Security Agreement, Grantor is required to execute and deliver this Agreement and to grant to the Agent a continuing security interest in all of the Trademark Collateral (as defined below) as part of the Collateral securing the Obligations; and

WHEREAS, Grantor has duly authorized the execution, delivery and performance of this Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor agrees, for the benefit of the Agent and each Noteholder, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Agreement, including its preamble and recitals, have the meanings provided in the Security Agreement.

SECTION 2. Trademarks. "Trademarks" shall mean and include the following described property now owned or hereafter acquired by Grantor, or in which Grantor now or hereafter has any right, title or interest: all trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, logos and other source or business identifiers, and all goodwill associated therewith, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all applications in connection therewith, whether in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State thereof or any other country or any political subdivision thereof, or otherwise, and all common-law rights related thereto; and the right to obtain all renewals thereof.

SECTION 3. Grant of Security Interest. Grantor hereby grants to the Agent, for its benefit and the ratable benefit of each Noteholder as a secured party, a continuing security interest in all of the Grantor's right, title and interest throughout the world, whether now or hereafter existing or acquired by such Grantor, in and to the following ("Trademark Collateral"):

(a) all Trademarks (including those Trademarks referred to in Schedule I applicable to Grantor);

(b) the right to sue third parties for past, present and future infringements or dilution of the Trademarks or for any injury to the goodwill associated with the use of any such Trademark; and

(c) all proceeds of, and rights associated with, the foregoing (including proceeds, licenses, royalties, income, payments, claims, damages and proceeds of infringement suits).

SECTION 4. Security Agreement. This Agreement has been executed and delivered by each Grantor for the purpose of registering the security interest of the Agent in the Trademark Collateral with the United States Patent and Trademark Office and, if applicable and reasonable, corresponding offices in other countries of the world. The security interest granted hereby has been granted as a supplement to, and not in limitation of, the security interest granted to the Agent for its benefit and the ratable benefit of each Noteholder under the Security Agreement. The Security Agreement (and all rights and remedies of the Agent and each Noteholder thereunder) shall remain in full force and effect in accordance with its terms. Further, this Agreement shall (unless otherwise expressly indicated herein) be construed, administered and applied in accordance with the terms and provisions of the Security Agreement.

SECTION 5. Acknowledgment. Grantor does hereby further acknowledge and affirm that the rights and remedies of the Agent with respect to the security interest in the Trademark Collateral granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein.

SECTION 6. Governing Law. **THIS AGREEMENT AND ALL CLAIMS SHALL BE GOVERNED AND CONSTRUED IN ACCORDANCE WITH THE GOVERNING LAW SECTION OF THE SECURITY AGREEMENT.**

SECTION 7. Counterparts. This Agreement may be executed in counterparts, each of which shall constitute an original, but all of which when taken together shall constitute a single contract. This Agreement shall become effective when Agent has received counterparts bearing the signatures of all parties hereto. Agent may (but shall have no obligation to) accept any signature, contract formation or record-keeping through electronic means, which shall have the same legal validity and enforceability as manual or paper-based methods, to the fullest extent permitted by Applicable Law, including the Federal Electronic Signatures in Global and National Commerce Act, the New York State Electronic Signatures and Records Act, or any similar state law based on the Uniform Electronic Transactions Act.







