4. **Assignment of Domain Names and Social Media Accounts.** For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignors do hereby irrevocably transfer, assign and convey to Assignee, and Assignee accepts the transfer, assignment and conveyance of all of Assignors' Domain Names and Social Media Accounts, all goodwill of Assignors symbolized by the Domain Names and Social Media Accounts, all rights to sue for infringement of the Domain Names and Social Media Accounts, whether arising prior to or subsequent to the Effective Date, and any and all renewals and extensions thereof that may hereafter be secured under the laws now or hereafter in effect in the United States, Canada and in any other jurisdiction, the same to be held and enjoyed by the said Assignee, its successors and assigns from and after the Effective Date, as fully and entirely as the same would have been held and enjoyed by the said Assignors had this Assignment not been made.
