**RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST**

RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST dated as of February 11, 2019 (this "***IP Security Release***"), by WELLS FARGO BANK, NATIONAL ASSOCIATION (the "***Collateral Agent***") in favor of the entities listed on Schedules A and B hereto (the "***Grantors***"). Reference is made to (a) that certain Security Agreement dated as of May 1, 2013 (as amended, modified, restated or supplemented from time to time, the "***Security Agreement***") among Caraustar Industries, Inc. (the "***Borrower***"), the other Grantors (as defined therein) from time to time party thereto and the Collateral Agent, (b) that certain Grant of Security Interest in United States Patents dated as of May 1, 2013 (the "***2013 Caraustar Custom Packaging Patent Security Agreement***"), between Caraustar Custom Packaging Group, Inc., a Delaware corporation, and the Collateral Agent, (c) that certain Grant of Security Interest in United States Patents dated as of May 1, 2013 (the "***2013 Caraustar Industrial and Consumer Products Patent Security Agreement***"), between Caraustar Industrial and Consumer Products Group, Inc., a Delaware corporation, and the Collateral Agent, (d) that certain Grant of Security Interests in United States Patents dated as of May 1, 2013 (the "***2013 Caraustar Industries Patent Security Agreement***"), between Caraustar Industries, Inc., a Delaware corporation, and the Collateral Agent, (e) that certain Grant of Security Interests in United States Trademarks dated as of May 1, 2013 (the "***2013 Trademark Security Agreement***"), between Caraustar Industries, Inc., a Delaware corporation, and the Collateral Agent, (f) that certain Grant of Security Interests in United States Patents dated as of February 17, 2015 (the "***2015 Patent Security Agreement***"), between The Newark Group, Inc., a New Jersey Corporation, and the Collateral Agent and (g) that certain Grant of Security Interests in United States Trademarks dated as of February 17, 2015 (the "***2015 Trademark Security Agreement***"), and together with the Security Agreement, the 2013 Caraustar Custom Packaging Patent Security Agreement, the 2013 Caraustar Industrial and Consumer Products Patent Security Agreement, the 2013 Caraustar Industries Patent Security Agreement, the 2013 Trademark Security Agreement and the 2015 Patent Security Agreement, the "***ABL Security Documents***"), between The Newark Group, Inc., a New Jersey Corporation, and the Collateral Agent.

WHEREAS, pursuant to the terms and conditions of the ABL Security Documents, the Grantors granted to the Collateral Agent a security interest in and to all of such Grantor's right, title and interest in, to and under any and all of the following (collectively, the "***Released IP Collateral***"):

- (a) the patents and patent applications set forth on Schedule A hereto (the "***Patents***");
- (b) the trademark and service mark registrations and applications set forth on Schedule B hereto (the "***Trademarks***");
- (c) all Proceeds (as such term is defined in the Security Agreement) and products of the Patents and Trademarks;
- (d) the goodwill of the business with which the Patents and Trademarks

are associated; and

(e) all causes of action for past, present and future infringement, or dilution of, or other injury to, any of the Patents or Trademarks or unfair competition regarding the same.

WHEREAS, the security interest in the Released IP Collateral was recorded with the United States Patent and Trademark Office on May 3, 2013 at Reel/Frame 030342/0940, Reel/Frame 030342/0861, Reel/Frame 030342/0915 and Reel/Frame 5020/0533 and on February 19, 2015 at Reel/Frame 035049/0465 and Reel/Frame 5462/0731.

WHEREAS, Collateral Agent now desires to execute and deliver this IP Security Release to evidence the release of its lien on and security interest in and to the Released IP Collateral identified in Schedules A and B attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent and the Grantors hereby agree as follows:


