## CONFIRMATION OF A SECURITY INTEREST IN INTELLECTUAL PROPERTY

### RECITALS:

- A. Bregnerød Investeringselskab ApS ("**BI**"), a corporation duly registered under the laws of Denmark having an office at Bohlendachvej 30, 1437 Copenhagen K, Denmark, granted a demand loan in the total amount of one million two hundred thousand dollars (\$1,200,000) to Cycles Argon-18 Inc. ("**Cycles**") pursuant to a loan agreement dated as of December 10, 2018 (the "**Loan**").
- B. Cycles is a shareholder of Notio Technologies Inc. (the "**Guarantor**"), a company duly incorporated and existing under the laws of Canada, whose head office is located at 208-6833, De L'Épée Avenue, Montreal, Province of Quebec, H3N 2C7, and BI is the majority shareholder of Cycles.
- C. The Guarantor is the owner of the trademark application set forth in Schedule A hereto (the "**Intellectual Property**").
- D. The Guarantor has entered into a guarantee agreement (the "**Guarantee Agreement**"), dated December 10, 2018, to guarantee the obligations of Cycles under the Loan, and a universal movable hypothec (the "**Security Interest**"), dated December 10, 2018, with BI pursuant to which the Guarantor has granted a hypothec in the universality of all of its movable property, including the Intellectual Property, in favour of BI.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are acknowledged, the Guarantor confirms the following:


