## CONFIRMATORY TRADEMARK ASSIGNMENT

This **CONFIRMATORY TRADEMARK ASSIGNMENT** (the "Trademark Assignment"), effective as of 2 July 2018, is by and between **ELSEVIER LIFE SCIENCES IP LIMITED**, a company incorporated in England and Wales, with a principal place of business at The Boulevard, Langford Lane, Kidlington, Oxford, OX5 1GB and company number 10535435 ("Assignor") and **ELSEVIER LIMITED**, a company incorporated in England and Wales, with a principal place of business at The Boulevard, Langford Lane, Kidlington, Oxford, OX5 1GB and company number 01982084 ("Assignee", together with Assignor, the "Parties", and each individually, a "Party").

**WHEREAS**, Assignor and Assignee are parties to that certain IP Assignment effective on 2 July 2018 pursuant to which Assignor has agreed to sell, convey, assign, transfer and deliver to Assignee, and Assignee has agreed to purchase, acquire and accept, all of Assignor's right, title and interest in and to the trademarks and trademark applications listed on Schedule A hereto (the "Trademarks") among other intellectual property assets;

**WHEREAS**, Assignor desires to sell, convey, assign, transfer and deliver to Assignee, and Assignee desires to purchase, acquire, receive and accept from Assignor, all of Assignor's right, title and interest in and to the Trademarks.

**NOW, THEREFORE**, in consideration of the foregoing and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties, intending to be legally bound hereby, agree as follows:

1. Assignment. Assignor does hereby sell, convey, assign, transfer and deliver unto Assignee all of Assignor's worldwide right, title and interest in, to and under the Trademarks, including all registrations and applications thereof and the goodwill symbolized thereby, all rights of priority and renewals, and together with all causes of actions, claims and demands, and all other rights to sue and recover for or rights arising from, any past, present, and future infringements, misappropriations, dilutions, unlawful imitations and all other violations of the Trademarks, the same to be held and enjoyed by the Assignee, its successors and assigns from and after the date hereof as fully and entirely as the same would have been held and enjoyed by the Assignor had this assignment of the Trademarks not been made.

2. Recordation. Assignor hereby requests and authorizes the Commissioner of Patents and Trademarks, and any other applicable governmental authority, to record Assignee as the owner of the Trademarks, as assignee of the entire right, title and interest in and to the same. Assignee shall have the right to record this Trademark Assignment with all applicable governmental authorities so as to perfect its ownership of the Trademarks.

3. Counterparts: Effectiveness. This Trademark Assignment may be signed in any number of counterparts, each of which shall be an original, with the same effect as if the signatures thereto and hereto were upon the same instrument. This Trademark Assignment shall become effective when each Party hereto shall have received a counterpart hereof signed by the other Parties hereto. For the convenience of the Parties, any number of counterparts hereof may be executed, each such executed counterpart shall be deemed an original and all such counterparts together shall constitute one and the same instrument. Facsimile transmission (including the e-mail delivery of documents in Adobe PDF format) of any signed original counterpart or retransmission of any signed facsimile transmission shall be deemed the same as the delivery of an original.
