## RELEASE OF SECURITY INTEREST IN TRADEMARKS

March 4, 2019

**WHEREAS**, SPARTON CORPORATION, an Ohio corporation (the “Corporation”) and the other Grantors party thereto entered into that certain Amended and Restated Security Agreement dated as of September 11, 2014 (as amended, amended and restated, restated, supplemented modified or otherwise in effect from time to time (the “Agreement”), with BMO Harris Bank, N.A., a national banking association, as administrative agent (the “Administrative Agent”), and the other parties thereto. Capitalized terms used herein but otherwise not defined herein shall have the meanings ascribed to them in the Agreement;

**WHEREAS**, pursuant to the Agreement, the Corporation executed and delivered to the Administrative Agent that certain Grant of Security Interest in Trademark Rights, dated as of September 11, 2014 (as amended, amended and restated, restated, supplemented modified or otherwise in effect from time to time the “Grant”), which Grant was recorded with the United States Patent and Trademark Office on September 18, 2014 at Reel 5365, Frame 0314; and

**WHEREAS**, pursuant to the Grant and the Agreement, the Corporation granted to the Administrative Agent a security interest in, and a right of setoff against, the Collateral (as defined in the Grant), including, without limitation, the trademarks identified on Schedule A attached hereto and the other trademarks and trademark licenses owned by the Corporation.

**NOW, THEREFORE**, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, without representation, warranty or recourse, hereby terminates, releases, relinquishes and discharges its security interest in, and right of setoff against, the Collateral (as defined in the Grant), including, without limitation, in the trademarks identified on Schedule A attached hereto and the other trademarks and trademark licenses owned by the Corporation, effective as of the date first set forth above.

The Administrative Agent acknowledges and hereby authorizes the Corporation or an agent of the Corporation to record this document with the United States Patent and Trademark Office to evidence the termination and release granted herein.
