**TRADEMARK, SOCIAL MEDIA ACCOUNTS, AND DOMAINS  
ASSIGNMENT TRANSFER AGREEMENT**

This Trademark, Social Media Accounts, and Domains Assignment Agreement ("Assignment") is made effective as of December 19, 2018 by Epic Holdings, LLC., a Florida Limited Liability Corporation, doing business at 18011 Biscayne Blvd., Suite 701, Aventura, Florida 33160 and to the extent necessary Dean Parsons, an individual, ("ASSIGNOR"), and Zander-Greg, Inc., a California corporation with a business address of 2830 East Foot Hill Blvd., Pasadena, California 91107 ("ASSIGNEE");


WHEREAS, ASSIGNOR is the owner of the trademarks (hereinafter referred to as "the Marks"), and other intellectual property and common law rights derived from the trademark used in association with Social Media Accounts and Internet Domains (jointly referred with the Marks as "the Property") as described in Exhibit A, attached hereto and incorporated by reference herein, together with the goodwill of the business symbolized thereby in connection with the goods and services on which the Marks are used;

WHEREAS, ASSIGNOR desires to convey, transfer, assign, deliver, and contribute to ASSIGNEE all of their right, title, and interest in and to the Marks and the Property.

NOW, THEREFORE, in consideration of the payment of One (1) Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency to be acknowledged at the time of receipt, ASSIGNOR hereby conveys, transfers, assigns, delivers, and contributes to ASSIGNEE all of ASSIGNOR'S right, title, and interest of whatever kind in and to the Marks and the Property, together with (1) the goodwill of the business relating to the Products in respect upon which the Marks and Property are used and for which they are registered including the common law rights derived from the use of the Property as of the date of first use; (2) all income, royalties, and damages hereafter due or payable to ASSIGNOR with respect to the Marks and Property, including without limitation, damages and payments for past or future infringements and misappropriations of the Marks and Property; (3) all rights to sue for past, present and future infringements or misappropriations of the Marks and Property; (4) all rights of renewal and associated rights to the Marks; and (5) all rights of access and use of the Social Media accounts and Internet Domains.

ASSIGNOR further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing, or vesting in ASSIGNEE full right, title, and interest in the Marks and the Property.

This Agreement includes any Product inventory and associated packaging materials, marketing materials, and/or other materials used in connection with the



Marks and the Property. Therefore, ASSIGNOR, either alone or through affiliates, agrees and conveys that all packaging, advertising and labeling of any existing or remaining Product inventory bearing the Marks and Property will be transferred to Assignee's warehouse and care within seven (7) days, or any other mutually agreeable time frame, after execution of this Agreement by the parties.

Further ASSIGNOR warrants and represents to be the sole and exclusive owner of the Marks and Property and further that the Marks and Property do not infringe any trademark or any intellectual property rights of third parties in connection to the Products bearing the Marks and Property including there have been no claims derived from their use of the Marks and Property in the United States and there are no outstanding or new trademark infringement claims, Internet Domain Disputes, or other cloud of title on same and/or the Social Media Accounts as of the date of execution of this Agreement.

IN WITNESS WHEREOF, the parties have duly executed under seal and delivered this Assignment, as of the day and year first above written.



