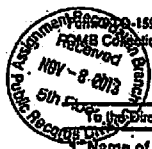

CORRECTIVE TRADEMARK ASSIGNMENT

THIS CORRECTIVE TRADEMARK ASSIGNMENT ("Corrective Trademark Assignment"), is made by and between My Patriot Supply, an Indiana sole proprietorship composed of Matthew Parker, U.S. Citizen ("Assignor") and Patriot Supply Store, Inc., a Nevada corporation ("Assignee") and is effective as of October 17, 2013.

WHEREAS, Assignor assigned the trademark and trademark registration set forth on Exhibit 1 hereto (the "Trademark") and attached as Exhibit 2, but inadvertently listed the incorrect Assignor (*see* Declaration in Exhibit 3); and

WHEREAS, Assignor assigned its entire right, title, and interest in the Trademark to Assignee in connection with a corporate reorganization on October 17, 2013 and the parties incorporate each of the terms set forth in Exhibit 2, as amended to include the correct Assignor;



I, Matthew Parker (AKA Matthew Redhawk), being hereby warned that willful false statements and the like are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code, and that such willful false statements and the like may jeopardize the validity of this document or any registration resulting therefrom, declares as follows:

1. I am the CEO of Patriot Supply Store, Inc. ("Registrant") and I am authorized to execute this declaration on its behalf.
2. In my position as CEO of Registrant, I am familiar with Registrant's corporate structure and use and ownership of the PATRIOT PANTRY mark as designated in U.S. Reg. No. 4,383,360.
3. On December 3, 2012, My Patriot Supply filed U.S. Application Serial No. 85/793,484 for PATRIOT PANTRY.
4. At the time of filing, My Patriot Supply was a sole proprietorship organized under the laws of the State of Indiana.
5. At the time of filing, Matthew Parker, a U.S. citizen, was the sole owner of My Patriot Supply.
6. On October 17, 2013, Matthew Parker and My Patriot Supply assigned ownership of U.S. Reg. No. 4,383,360 to Patriot Supply Store, Inc., a corporation organized under the laws of the State of Nevada.
7. On November 8, 2013, the assignment was recorded with the United States Patent and Trademark Office, as shown at Reel No. 5160/Frame No. 0124, where the original cover sheet and underlying assignment document can be found.
8. However, the recorded assignment document incorrectly shows Matthew Parker, in his individual capacity, transferring ownership of Reg. No. 4,383,360, rather than My Patriot Supply, a sole proprietorship.
9. Naming the original owner as Matthew Parker in his individual capacity in the assignment document was an inadvertent error, made in good faith.


10. The correct current owner Patriot Supply Store, Inc. has been and continues to be the owner of Reg. No. 4,383,360 since October 17, 2013, the execution date of the assignment. Ownership of the registration has not transferred since that date and chain of title remain with Patriot Supply Store, Inc.
