Pursuant to Section 264(c) of the General Corporation Law of the State of Delaware (the "DGCL") and Section 18-209(c) of the Limited Liability Company Act of the State of Delaware (the "LLC Act"), the undersigned company, organized and existing under and by virtue of the LLC Act, does hereby certify as follows:

FIRST: The name, state of organization and entity type of each of the constituent entities of the merger is as follows:

SECOND: An Agreement and Plan of Merger (the "Merger Agreement"), dated as of April 29, 2018, as amended, by and among Marathon Petroleum Corporation (the "Parent"), Mahi Inc. ("Merger Sub 1"), Mahi LLC (now known as Andeavor LLC or "Merger Sub 2") and Andeavor (the "Company", and, together with Merger Sub 2, the "Merging Entities"), has been approved, adopted, certified, executed and acknowledged by each of the Merging Entities in accordance with Section 264 of the DGCL and Section 18-209 of the LLC Act.

THIRD: The name of the surviving company following the merger of the Company with and into Merger Sub 2 shall be Andeavor LLC, a Delaware limited liability company (the "Surviving Company").

FOURTH: Upon effectiveness of the merger, the certificate of formation of Merger Sub 2 in effect immediately prior to the effectiveness of the merger shall be the certificate of formation of the Surviving Company until thereafter amended as provided therein or by applicable law.

FIFTH: The merger is to become effective upon the filing of this Certificate of Merger.

SIXTH: The executed Merger Agreement is on file at the principal place of business of the Surviving Company, located at 19100 Ridgewood Pkwy, San Antonio, TX 78259.

SEVENTH: A copy of the Merger Agreement will be furnished by the Surviving Company, on request and without cost, to any member of or any person holding interest in either of the Merging Entities.
