## RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of March 18, 2019 (the "Release"), is made by MANUFACTURERS AND TRADERS TRUST COMPANY, in its capacity as Administrative Agent for itself as a Secured Party and on behalf of the other Secured Parties (together with its successors and assigns, the "Agent"), in connection with the termination of that certain Notice of Security Interests in Trademarks, dated as of January 17, 2017 (the "Security Agreement"), made by Gasco Affiliates, L.L.C., a Florida limited liability company (the "Grantor"), in favor of the Agent. Capitalized terms not defined herein shall have the meaning ascribed to them in the Security Agreement.

### WITNESSETH

WHEREAS, pursuant to the Security Agreement, which was recorded with the U.S. Patent and Trademark Office on January 19, 2017 at Reel 5970 / Frame 0122, the Grantor granted the Agent a security interest in (i) all right, title and interest in and to the Trademark Collateral, including the trademarks listed on Schedule I hereto, and (ii) the goodwill associated therewith or symbolized thereby (collectively (i) and (ii), the "Collateral");

WHEREAS, the credit facilities referred to in the Security Agreement have been terminated and the Grantor has requested that the Agent enter into this Release in connection with the termination of the Security Agreement.

NOW, THEREFORE, in consideration of the foregoing, the Agent hereby (i) releases, without representation, warranty or recourse, all of its and their security interests and liens in and to the Collateral, including without limitation the Collateral listed on Schedule I attached hereto and incorporated herein by reference, (ii) terminates the Security Agreement, and (iii) terminates any right, title and interest that Agent has in, to and under the Collateral.

This Release shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.

IN WITNESS WHEREOF, the Agent has executed this Release as of the date first set forth above.



