
2.5 the Goodwill and the Intellectual Property Rights;

6. This Assignment shall be governed by and construed in accordance with English law and the parties submit to the non-exclusive jurisdiction of the English courts in relation to all matters, claims and disputes arising out of or in connection with this Assignment.


