## TRADE MARK RIGHTS ASSIGNMENT

This Trade Mark Rights Assignment (“Assignment”), dated as of March 28, 2019 (“the Effective Date”), is entered into by and between Advantor Systems LLC (“Assignor”), a limited liability company organized and existing under the laws of the State of Delaware, whose business address is 12612 Challenger Pkwy, Suite 300, Orlando, Florida 32826, United States, and Veristream LLC (“Assignee”), a limited liability company organized and existing under the laws of the State of Delaware, whose business address is 3361 Rouse Road, Suite 245, Orlando, Florida 32817, United States.

### RECITALS

WHEREAS, Assignor has adopted, used, and is using the marks referenced in Schedule A, attached hereto, (“U.S. Registered Marks”), which are registered in the United States Patent and Trademark Office in connection with various security and visitor management software products and services, and having been designated Registration Numbers as set forth in the attached Schedule A; and

WHEREAS, Assignee is desirous of acquiring said U.S. Registered Marks and registrations therefor;

WHEREAS, Assignor has adopted and owns the marks referenced in Schedule B, attached hereto, (“Foreign Marks”) which are registered on the trade marks registers of the respective countries and jurisdictions set forth in the attached Schedule B in connection with various security and visitor management software products, and having been designated Registration Numbers as set forth in the attached Schedule B; and,

WHEREAS, Assignee is desirous of acquiring said Foreign Marks, and the registrations therefor;

NOW, therefore, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and in consideration of the mutual covenants and agreements herein contained, and intending to be legally bound hereby, Assignor and Assignee hereby agree as follows:


1. Assignment of United States Trademark Registrations. Assignor does hereby sell, assign, and transfer unto Assignee all right, title and interest in and to said U.S. Registered Marks, together with the goodwill of the business symbolized by the U.S. Registered Marks, and the registrations therefor.
2. Assignment of Worldwide Trade Mark Registrations. Assignor does hereby sell, assign, and transfer unto Assignee all right, title and interest in and to said Foreign Marks, together with the goodwill of the business symbolized by the Foreign Marks if any exists and to the extent required, and the registrations therefor which are referenced in the attached Schedule B.
3. Governmental Authorities. The U.S. Patent and Trademark Office, the trade mark offices of Canada, European Union, United Arab Emirates, World Intellectual Property Organization and all other Governmental Authorities with authority for the registration of the trade marks throughout the world shall be entitled to rely on this Assignment for the purpose of effecting a change in the registered owner the trademarks assigned hereby.

4. Further Assurances. Assignor, at the request of Assignee, shall execute and deliver such other instruments and do and perform such other acts and things as may be reasonably necessary or desirable for effecting the assignment and transfer of the trade mark rights in Assignee. Without limiting the foregoing, at any time or from time to time after the date hereof, at Assignee's request, Assignor shall at the expense of Assignor: (i) execute and deliver to Assignee such other instruments of sale, transfer, conveyance, assignment, and confirmation; provide such materials and information; and take such other actions as Assignee may reasonably deem necessary or desirable in order effectively to transfer, convey, and assign to Assignee, or to confirm Assignee's title to, all of the trade mark rights; (ii) provide reasonable assistance and information in connection with the filing, prosecution, and enforcement of the trade mark rights, and (iii) secure any consents, approvals, or authorizations necessary to ensure that all trade mark rights are effectively transferred to Assignee.

5. Governing Law. This Assignment shall be governed by and construed in accordance with the laws of the State of Florida, without regard to the choice of law principles thereof.
