Appthority hereby authorizes and requests the United States Commissioner of Patents and Trademarks and the relevant officials of foreign jurisdictions to implement this Assignment.

IN WITNESS WHEREOF, Appthority and Symantec have caused this Assignment to be made as of the effective date of the Assignment Agreement referenced above.






