## AFFIDAVIT TO AFFIRM THE RELEASE OF SECURITY AGREEMENT

This Affidavit to Affirm the Release of Security Agreement is effective as of April 10, 2019 pursuant to the fulfillment of the loan obligations.

I, Sung Tsei Chen, do hereby declare as follows:

1. I am the Chief Executive Officer of Markwins Beauty Brands, Inc., a California corporation, located at 22067 Ferrero Parkway, City of Industry, California 91789 ("Markwins Beauty Brands").
2. On April 30, 1998, Jonel Inc. (the "Pledgor") and Credit Agricole Indosuez, in its capacity as collateral agent (the "Collateral Agent") entered into that certain Subsidiary Intellectual Property Security Agreement which was recorded with the U.S. Patent and Trademark Office ("USPTO") on June 11, 1998 at Reel/Frame No. 1740/0475 (the "Agreement"), pursuant to which the Pledgor pledged, assigned, transferred and granted to the Collateral Agent a security interest in and to all of the right, title and interest of Pledgor in, to and under certain trademark registrations and applications, including those listed in the attached Exhibit A.
3. On February 28, 2003, the Pledgor and Markwins Beauty Products, Inc. ("Markwins Beauty Products") entered into that certain Assignment of Trademarks/Service Marks which was recorded with the USPTO on November 21, 2003 at Reel/Frame No. 2751/0415 (the "First Assignment"), pursuant to which the Pledgor assigned and transferred ownership of certain trademark registrations and applications, including those listed in the attached Exhibit A to Markwins Beauty Products.
4. On January 6, 2004, Markwins Beauty Products and Markwins International Corporation ("Markwins International") entered into that certain Assignment of Trademarks/Service Marks which was recorded with the USPTO on January 9, 2004 at Reel/Frame No. 2776/0139 (the "Second Assignment" and together with the First Assignment, the "Assignments"), pursuant to which Markwins Beauty Products assigned and transferred ownership of certain trademark registrations and applications, including those listed in the attached Exhibit A to Markwins International.
5. On November 28, 2016, Markwins International changed its name to Markwins Beauty Brands, Inc. ("Markwins Beauty Brands") which was recorded with the USPTO on May 18, 2017 at Reel/Frame No. 6062/0882 (the "Name Change").
6. To the best of my knowledge, the obligations secured under the Agreement were satisfied prior to the Assignments and Name Change.

7. Due to unknown reasons, a release of the Agreement was not filed with the USPTO.

The undersigned, being hereby advised that willful false statements and the like so made are punishable by fine or imprisonment, or both, under 18 U.S.C. 1001, declares that the facts set forth in this Declaration are true; all statements made of his/her own knowledge are true; and all statements made on information and belief are believed to be true.
