Assignor further agrees to provide all evidence upon request by Assignee, including any use in commerce (or lack thereof) of any of the intellectual property, which would be reasonably required to maintain, renew, or otherwise establish any new filings thereof.

This assignment and agreement shall be binding upon our heirs and legal representatives and shall be effective as of **December 30, 2018** (the "Effective Date").


