1. DEFINITIONS

- "Intellectual Property" shall mean, whether listed in attached Appendix A or b. otherwise (a) all inventions (whether patentable or unpatentable and whether or not reduced to practice), all improvements thereto, and all patents, patent applications, patent disclosures and invention disclosures, together with all reissuances, continuations, continuations-in-part, divisionals, revisions, extensions, reissues and reexaminations thereof, (b) copyrights and other works (including literary works, pictorial, graphic and sculptural works, architectural works and works of visual art) that are or may be the subject matter of copyright protection, including, but not limited to, designs, images, pictorial works, labels, and websites, (c) advertising concepts, marketing concepts, information, data, formulae, designs, design concepts, models and drawings (including all documentation, related listings, design specifications and flowcharts), (d) computer programs and software (including rights in any third-party software), (e) trade secrets and confidential and proprietary information, (f) know-how, patents and inventions (including all processes, methods of use, developments, designs, improvements, discoveries, machines, manufactures and compositions of matter) that may be the subject matter of patent protection or other protection under applicable Law, (g) trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, service marks, trade names, logos, designs and any other source or business identifiers, domain names and Internet Universal Resource Locators, together with the goodwill of the business symbolized thereby and associated therewith (collectively, referred to herein as the "Trademarks," including, but not limited to, those trademark applications and registrations listed in Appendix A), (h) other


