(d) all enforcement rights that arise from the assigned rights in The Trademark, The Trademark Registration, and the Trademark Application.

7. **Assignor** will execute and deliver to **Assignee** or its legal representatives any and all assets, instruments, or affidavits required to apply for, obtain, maintain, register, and/or enforce the assigned rights.


9. **Assignor** covenants that no assignment, sale, agreement, or encumbrance has been or will be made or entered into which would conflict with this Assignment.


