NOTICE OF MERGER OF LIMITED LIABILITY COMPANY


Pursuant to the provisions of Chapter 347 of the Revised Statutes of Missouri, the undersigned limited liability companies certify the following:



 - a. Article 4 of the Articles of Organization of Surviving Entity is hereby deleted in its entirety and the following inserted therefor:



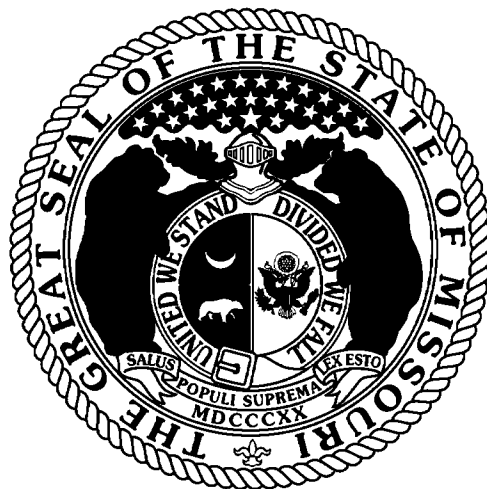
