RELEASE OF TRADEMARK SECURITY INTEREST

This **RELEASE OF TRADEMARK SECURITY INTEREST** is made as of May 14, 2019 by AB PRIVATE CREDIT INVESTORS LLC, as Collateral Agent for the Lenders ("Secured Party").

WITNESSETH:

WHEREAS, Veriforce, LLC, a New Mexico limited liability company ("Veriforce"), and Veriforce Holdings, LLC, a Delaware limited liability company ("Holdings" and, together with Veriforce, collectively, the "Grantors") and Secured Party are parties to that certain Pledge and Security Agreement, dated as of July 13, 2018 (the "Security Agreement");

WHEREAS, in connection with the Security Agreement, Secured Party and Veriforce are parties to that certain Trademark Security Agreement, dated as of July 13, 2018 (the "Trademark Security Agreement"), pursuant to which Veriforce granted a security interest to Secured Party in the Trademark Collateral (as defined in the Trademark Security Agreement) set forth in Schedule I attached hereto;

WHEREAS, Secured Party recorded the Trademark Security Agreement with the United States Patent and Trademark Office on July 13, 2018 at Reel/Frame 6380/0653; and

WHEREAS, Secured Party has agreed to release its rights under the Trademark Security Agreement and to re-convey to Veriforce any and all rights in and to the Trademark Collateral.

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

1. Secured Party hereby terminates, releases and discharges its security interest in all the Trademark Collateral originally granted to Secured Party pursuant to the Security Agreement and the Trademark Security Agreement and releases all other rights it may have to the Trademark Collateral under the Security Agreement and the Trademark Security Agreement.


2. Secured Party, to the extent granted in the Security Agreement or the Trademark Security Agreement, hereby assigns, grants and otherwise re-conveys to Veriforce, without any representation, recourse or undertaking by Secured Party, all of its right, title and interest in and to the Trademark Collateral originally granted to Secured Party pursuant to the Security Agreement or the Trademark Security Agreement.

3. Upon the request of Grantors, Secured Party, at Grantors' expense, further agrees to execute all documents necessary to demonstrate and confirm the parties' intent under this Release of Trademark Security Interest.
