**AGREEMENT AND PLAN OF MERGER  
OF  
KLUBER LUBRICATION NORTH AMERICA L.P.  
WITH AND INTO  
KL TEXAS, L.P.**

Effective as of 12:03 a.m. on January 1, 2015

This Agreement and Plan of Merger is made effective as 12:03 a.m. on January 1, 2015 (this "*Plan of Merger*"), between Kluber Lubrication North America LP, a Delaware limited partnership ("*KLNA*") and KL Texas, L.P., a Delaware limited partnership ("*KLTX*").

KLNA and KLTX desire to effect a merger of KLNA with and into KLTX (the "*Merger*") pursuant to the Delaware Revised Uninform Limited Partnership Act ("*Delaware Law*"), and subject to the terms and conditions set forth in this Plan of Merger.

NOW THEREFORE, in consideration of the foregoing, and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties hereto agree as follows:

1. **Effective Time.** The Merger shall become effective on the time the Certificate of Merger is accepted as filed by the State of Delaware, which will be filed in advance of the Effective Time and will state that the future effective time of the merger shall be 12:03 a.m. on January 1, 2015 (the "*Effective Time*").

2. **Surviving Entity.** KLTX shall be the surviving entity (the "*Surviving Entity*") in the Merger.

3. **Terms of Merger.**

(a) **Approval by KLNA.** This Plan of Merger has been approved by the partners of KLNA in the manner provided by its Agreement of Limited Partnership and Delaware Law.

(b) **Approval by KLTX.** This Plan of Merger has been approved by the partners of KLTX in the manner provided by its Agreement of Limited Partnership and Delaware Law.

(c) **Status of KLNA Partnership Interests.** All partnership interests of KLNA which shall be issued and outstanding immediately before the Effective Time shall, by virtue of the Merger and without any action on the part of its owners be cancelled and exchanged for interests in KLTX.

(d) **Status of KLTX Partnership Interests.** All partnership interests of KLTX which shall be issued and outstanding prior to the Effective Time shall continue to exist and remain issued and outstanding.

4. **Amendments to Certificate of Limited Partnership and Agreement of Limited Partnership.** The Certificate of Limited Partnership and Agreement of Limited Partnership in

effect immediately prior to the Effective Time shall be the Certificate of Limited Partnership and Agreement of Limited Partnership of the Surviving Entity.

5. **Termination.** Subject to applicable law, this Plan of Merger may be abandoned at any time prior to the Effective Time by mutual consent of the parties hereto.
