ASSIGNMENT OF INTELLECTUAL PROPERTY

This Agreement shall serve as an automatic assignment to Assignee of all intellectual property identified in Appendices A and B.

Assignor, its successors, assigns, and other legal representatives agree to execute any and all papers, including applications for trademark, service mark or domain registrations of any and all kind and in any and all countries and to perform any and all acts which Assignee, its successors, assigns, or other legal representatives may deem necessary and reasonably requested to secure thereto the rights assigned herein.


