## RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS ("Release") is made as of this 31<sup>st</sup> day of May, 2019, by M&T BANK, a New York banking corporation ("Secured Party"), in favor of LSC ENVIRONMENTAL PRODUCTS, LLC, a Delaware limited liability company and TERRA NOVO, LLC, a Delaware limited liability company (collectively, the "Companies" and each individually, a "Company"). (i) all trademarks, trademark applications, trademark licenses, names, brand names, company names, fictitious names, trade names, product names, slogans, and all designs related thereto and all other corresponding rights, whether the same are domestic, international, or foreign, throughout the world, without limitation and not limited to, each trademark, trademark application, and trademark license referred to on Schedule A attached hereto;

(ii) all the foregoing together with any and all continuations, continuations-in-part, divisions, extensions, modifications, provisionals, reissues, renewals, or substitutions thereof, as applicable;


