NOW, THEREFORE, for good and valuable consideration as set forth in the Contribution and Distribution Agreement, the receipt and sufficiency of which are hereby acknowledged by Assignor and Assignee, Assignor hereby irrevocably assigns and transfers to Assignee, its successors and assigns, the entire worldwide right, title, and interest in and to the Contributed Marks together with the accompanying goodwill and that portion of the business represented and symbolized by the Contributed Marks, applications and registrations for the Contributed Marks, and all common law rights, together with all rights and privileges granted and secured thereby, including all rights to register, renew, defend, and protect interests therein under the applicable laws of all jurisdictions and all claims, demands, income, damages, royalties, payments, accounts and accounts receivable now or hereafter due and/or payable, and rights of action, both statutory and based upon common law, that Assignor has or might have by reason of any past, present, or future infringement or other unauthorized use of the Contributed Marks prior to, on, or after the date of this Assignment, together with the right to prosecute such claims, demands, and rights of action in Assignee's own name, all of said rights to be held and enjoyed by Assignee, for its own use and benefit and for the use and benefit of its successors, assigns or other legal representatives as fully and entirely as the same would have been held and enjoyed by Assignor if this Trademark Assignment had not been made.

Assignor does hereby authorize the Director of the United States Patent & Trademark Office, and the empowered official of any U.S. State, or any country or countries foreign to the United States whose duty it is to record trademark registrations, applications and title thereto, to record the Contributed Trademarks and title thereto as the property of Assignee, its successors, assigns or legal representatives, in accordance with the terms of this instrument.

Assignee and Assignor agree that multiple copies of this Trademark Assignment may be executed in counterparts, each of which shall be deemed an original and each of which shall be valid and binding upon Assignee and Assignor.


