This **INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT** (this "Assignment") is made and delivered as of April 4, 2019 (the "Effective Date") by Sailors for the Sea, Inc., a Massachusetts nonprofit corporation ("Sailors"), for the benefit of Oceana, Inc., a Washington D.C. nonprofit corporation ("Oceana").

WHEREAS, Sailors and Oceana have entered into that certain Asset Transfer Agreement, dated as of February 7, 2018 by and between Oceana and Sailors (the "Asset Transfer Agreement"); each term used but not defined herein shall have the meaning ascribed to it in the Asset Transfer Agreement.

WHEREAS, Sailors agreed to transfer, contribute and assign to the Oceana all of Sailors' right, title and interest in and to Sailors' intellectual property, including, but not limited to, the trademarks set forth on Exhibit A hereof (collectively, the "IP").

NOW, THEREFORE, the parties hereto do hereby agree as follows:

1. Sailors hereby irrevocably assigns to Oceana: (i) all of Sailors's right, title, and interest in and to the IP, together with the goodwill associated therewith; (ii) any and all legal actions and rights and remedies at law or in equity for past infringements, misappropriations, or other violations of the IP, including the right to sue for, collect, and retain all damages, profits, proceeds, and all other remedies associated therewith; and (iii) any and all income, royalties, and payments accruing prior to, on or after the Effective Date with respect to the IP for the Oceana's own use and enjoyment and for the use and enjoyment of the Oceana's successors, assigns, and other legal representatives. Sailors agrees to give Oceana and/or any person designated by Oceana all reasonable assistance that may be required to perfect the rights granted herein.

2. Sailors agrees not to use (and to terminate and discontinue all use of) the IP and the terms contained in the IP, and any terms similar thereto, in any domain name, domain name registration, trademark, service mark, trade name, company name, legal name, fictitious business name, logo, and any other indicator of origin, with regard to itself and any business or entity at any time owned or controlled by Sailors.

3. Sailors authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any other official throughout the world whose duty is to register and record ownership in trademark registrations and applications or other Intellectual Property for registration of trademarks or other Intellectual Property, as applicable, to record Oceana as the assignee and owner of any and all of Sailors' rights in the IP.

4. All of the terms and provisions of this Assignment shall inure to the benefit of and be binding upon the parties hereto and their respective successors and assigns.

5. No provision of this Assignment is intended to confer upon any person other than the parties hereto and their respective successors and assigns any rights or remedies hereunder.




