This Agreement sets forth the entire understanding of the parties with respect to the subject matter hereof and may be modified, amended, or terminated only by a writing signed by both parties. This Agreement is binding on and shall inure to the benefit of the parties hereto and their respective successors and assigns. If any provision hereof is determined invalid or unenforceable by a court of competent jurisdiction, that shall not affect the validity and enforceability of the remaining provisions hereof. This Agreement shall be deemed to be jointly drafted, and to the extent this Agreement is determined to contain any ambiguities, the ambiguities shall not be construed against either party hereto. This Agreement shall be governed by the laws of the state of Washington applicable to contracts entered into and performed wholly within the State of Washington. The federal and state courts in the State of Washington in King County shall have exclusive jurisdiction over all disputes between the parties hereto pertaining to this Agreement. This Agreement may be executed in counterparts, including by PDF email attachment or other facsimile copy, each of which shall be an "original" and all of which when taken together shall constitute the same instrument.
