RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is dated as of June 21, 2019 and delivered by **WELLS FARGO BANK, N.A.**, in its capacity as Administrative Agent for the Lenders under the Security Agreement referred to below (in such capacity, the "Agent"), in favor of **APRIA HEALTHCARE GROUP INC.**, a corporation formed under the laws of Delaware (the "Grantor"). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement (as defined below) or the Security Agreement (as defined below), as applicable.

WHEREAS, pursuant to that certain Security Agreement, dated as of May 2, 2014, (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement") among the Grantor, the Agent and certain other parties thereto, in order to secure payments of Secured Obligations (as defined in the Security Agreement), the Grantor assigned, pledged and granted to the Agent, for the ratable benefit of the Lenders, a continuing security interest in all of the Grantor's right, title and interest in, to or under all of its Trademarks including, without limitation, the trademarks and trademark applications listed on Schedule I hereto, in each case to the extent the same constitute Collateral (as defined in the Security Agreement) (the "Intellectual Property").

WHEREAS, the Grant of Security Interest in United States Trademarks, dated as of May 2, 2014, evidencing the security interest granted by the Grantor in favor of the Agent, was recorded with the United States Patent and Trademark Office on May 2, 2014 at Reel/Frame 5273/0372 (the "Trademark Security Agreement").

WHEREAS, the Agent hereby acknowledges the full payment and performance of the Secured Obligations, and as a result desires to terminate and release its security interest in the Intellectual Property.

NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent, on behalf of itself and the Lenders, hereby terminates, releases and forever discharges any and all security interests it has in the Intellectual Property and any other Trademarks (as defined in the Trademark Security Agreement), terminates the Trademark Security Agreement, and retransfers and reassigns to the Grantor without representation or warranty of any kind, express or implied, free and clear of any claims by the Agent, all right, title or interest the Agent for its benefit and the benefits of the Lenders may have obtained in, to or under the Intellectual Property and any other Trademarks of the Grantor.

This Release shall be governed by and construed in accordance with the laws of the State of New York.
