**FIRST AMENDMENT
TO
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This First Amendment to Intellectual Property Security Agreement is entered into as of August 15, 2018 (the "Amendment") by and between CANADIAN IMPERIAL BANK OF COMMERCE, a Canadian Bank, as successor in interest to WF Fund V Limited Partnership ("Lender"), TIGERCONNECT, INC., a Delaware corporation (formerly known as TIGERTEXT, INC.) ("Grantor").

RECITALS

Grantor and Lender are parties to that certain Intellectual Property Security Agreement dated as of April 12, 2017, as amended from time to time (the "IPSA"). The parties are entering into a Second Amendment to Loan and Security Agreement dated as of even date hereof (the "Second Amendment"). In connection with the Second Amendment, the parties desire to amend the IPSA in accordance with the terms of this Amendment.

NOW, THEREFORE, the parties agree as follows:

1. Exhibit B (Patents) to the IPSA is hereby replaced in its entirety with that attached hereto as Exhibit B.
2. Exhibit C (Trademarks) to the IPSA is hereby replaced in its entirety with that attached hereto as Exhibit C.
3. Unless otherwise defined, all initially capitalized terms in this Amendment shall be as defined in the IPSA. The IPSA, as amended hereby, shall be and remain in full force and effect in accordance with its respective terms and hereby is ratified and confirmed in all respects. Except as expressly set forth herein, the execution, delivery, and performance of this Amendment shall not operate as a waiver of, or as an amendment of, any right, power, or remedy of Lender's under the IPSA, as in effect prior to the date hereof. Grantor ratifies and reaffirms the continuing effectiveness of all agreements entered into in connection with the IPSA.
4. This Amendment may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one instrument. Delivery of an executed counterpart of a signature page of this Amendment or any document delivered in connection therewith by electronic means including by email delivery of a ".pdf" format data file shall be effective as delivery of an original executed counterpart thereof.
