**TERMINATION AND RELEASE OF SECURITY INTEREST IN
TRADEMARK RIGHTS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Termination and Release"), dated as of June 21, 2019, by BANK OF AMERICA, N.A. (the "Lender").

WITNESSETH:

WHEREAS, reference is made to that certain Credit Agreement dated as of January 8, 2019 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), by and among, among others, DEFINITIVE HEALTHCARE, LLC, a Massachusetts limited liability company (the "Borrower") and the Lender;

WHEREAS, pursuant to the Security and Pledge Agreement dated as of January 8, 2019 (the "Security Agreement"), a lien on and security interest (the "Security Interest") was granted by the Borrower to the Lender in certain collateral, including the trademarks and trademark applications shown on Schedule I attached hereto (collectively, the "Trademark Collateral");

WHEREAS, a Notice of Grant of Security Interest in Trademarks was recorded in the Trademark Division of the United States Patent and Trademark Office on January 28, 2019 at Reel/Frame 6537/0912.

WHEREAS, the Lender now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Lender hereby agrees as follows:


1. Release of Security Interest. The Lender, without representation, warranty or recourse, hereby terminates, releases and discharges any and all Security Interest in the Trademark Collateral, and any right, title or interest of the Lender in such Trademark Collateral shall hereby cease and become void.

2. Recordation. The Lender authorizes the Borrower or its designee to record this Termination and Release with the United States Patent and Trademark Office or any other applicable governmental authority at the Borrower's expense.


