**NUNC PRO TUNC ASSIGNMENT AGREEMENT**

This Nunc Pro Tunc Assignment Agreement, effective September 28, 2018, is entered into by and between **Societe des Produits Marnier Lapostolle**, a French société anonyme with historic addresses of 91 Boulevard Haussmann, Paris 75008, France and 32 rue de Monceau - 75008 Paris, France ("**Assignor**") and **Marnier-Lapostolle Bisquit f/k/a Bisquit Dubouché et Cie**, a French société anonyme with a historic address of 90 boulevard de Paris, Cognac, 16100, France and a current address of 32 rue de Monceau - 75008 Paris, France ("**Assignee**").



As of September 28, 2018, Assignor assigns, transfers, and conveys to Assignee, Assignor's entire right, title, and interest in and to the Trademarks, including the trademark registrations listed in Exhibit A. The parties intend the Trademarks to be held and enjoyed by Assignee, its successors and assigns from and after September 28, 2018.
