SECOND The name of the Corporation (hereinafter, the "Corporation") is

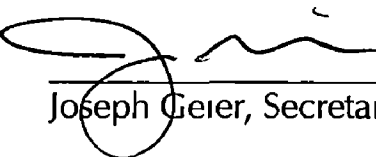

THIRD These Articles of Amendment shall be effective as of the date upon which the Department accepts these Articles of Amendment for record

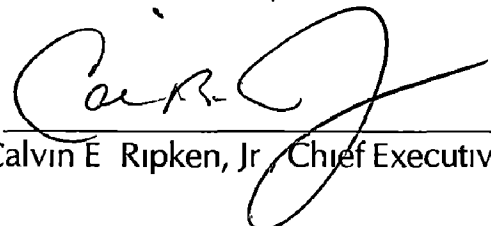
